1. Purpose of the Policy

This Policy establishes the criteria for entry to the annual NSWISA State Championships. The Policy outlines the eligibility of all skaters intending to participate in the Championships, both NSWISA Members and Guests.

2. Application of the Policy

This Policy applies to all eligible NSWISA Members and Guests of other State Associations and ISU Members. This Policy applies to all divisions forming part of the Championships.

3. Eligibility

To be eligible to enter the NSWISA State Championships, competitors must meet the following criteria as at close of entries for the Championships:

Singles, Pairs & Ice Dance:

- Each skater must be a financial Member of NSWISA or another State Association or ISU Member and a home Club
- Each skater must hold the relevant ISA test level to compete as per the relevant ISA By-Laws
- For NSWISA Members, each skater must have competed in at least two IJS technical events in NSW in the calendar year of the Championships.
- For Guests, entries must be approved by the skater's/skaters Association/Member and will be approved by the Championship Organising Committee after consideration

In cases of exceptional circumstances where skaters are not able to meet the above criteria, applications may be made to the NSWISA Board and Championship Organising Committee for review. Supporting documentation may be required.

Synchronized Skating:

- Team Members must be financial Members of NSWISA or another State Association or ISU Member and a home Club
- Teams must meet the ISA requirements for Team Composition as per ISA By-Laws Section 10
- For NSWISA Members, teams must have competed in at least one SYS IJS event in NSW in the calendar year of the Championships.
- For Guests, entries must be approved by the team's Association/Member and will be approved by the Championship Organising Committee after consideration

In cases of exceptional circumstances where teams are not able to meet the above criteria, applications may be made to the NSWISA Board and Championships Organising Committee for review. Supporting documentation may be required.

Theatre On Ice:

- Team Members must be financial Members of NSWISA or another State Association or ISU Member and a home Club
- Teams must meet the ISA requirements for Team Composition as per ISA By-Laws Section 12
- For NSWISA Members, teams must have competed in at least one TOI IJS event in NSW in the calendar year of the Championships.
- For Guests, entries must be approved by the team's Association/Member and will be approved by the Championship Organising Committee after consideration

In cases of exceptional circumstances where teams are not able to meet the above criteria, applications may be made to the NSWISA Board and Championships Organising Committee for review. Supporting documentation may be required.

4. Entries

Entries to the NSWISA State Championships must be made using the NSWISA online registration system available at www.nswisa.com. PPC(s), music and payment must all be submitted at the time of entry for the entry to be accepted.
