### **1. Purpose of the Policy**

This Policy establishes the criteria for funding for NSWISA Officials. The Policy outlines the eligibility for funding of all persons officiating at NSWISA Affiliated Club, NSWISA, ISA or ISU events.

### **2. Application of the Policy**

This Policy applies to all eligible NSWISA Members who Officiate at events. This Policy applies to all events run in each calendar year by NSWISA Affiliated Clubs NSWISA, ISA or ISU. Members will be considered as Officiating if they act as a:

- Referee
- Judge
- Trial Judge
- Technical Controller
- Technical Specialist
- Assistant Technical Specialist
- Data Entry Operator
- Video Replay Operator
- Accountant
- IJS Support Personnel
- NSWISA Appointed Competition Convenor

### **3. Eligibility**

To be eligible for funding from NSWISA Officials must:

- Be a current financial Member of NSWISA
- Be a current financial Member of NSWISA with at least two (2) years standing for any events where the available funding for the activity is greater than \$100 in the Funding List
- Reside within the state of NSW
- Be on the list of current NSWISA Officials

- Have officiated at a minimum of six (6) events within NSW including at least:
  - 1 x Benchmark Event
  - 2 x Club IJS Events (excluding Benchmark Events)
  - 1 x Artistic Competition
  - 1 x Aussie Skate Competition
  - 1 x Test Session
  
- For 2020 ONLY, have officiated at a minimum of five (5) events within NSW including at least:
  - 1 x Benchmark Event
  - 2 x Club IJS Events (excluding Benchmark Events)
  - 1 x Aussie Skate Competition
  - 1 x Test Session

For Aussie Skate Judges only, eligibility for funding applies when the Judge has officiated at a minimum of three (3) NSWISA Aussie Skate Competitions.

For roles which only exist at IJS events, and where the individual does not act in a role that exists at non-IJS events, eligibility for funding applies when the individual has officiated at a minimum of three (3) events being:

- 1 x Benchmark Event<sup>^</sup>
- 2 x Club IJS Events (excluding Benchmark Events & for singles skating only) <sup>^</sup>

## **4. Funding**

The Funding available per Official is:

<b>Event</b>	<b>Funding</b>
Tests	\$30 per session
NSWISA Aussie Skate Competitions	\$30 per session
NSWISA Competitions & Championships	\$30 per day <sup>^</sup>
IJS Event Set Up – Data or Music	\$100 per event
Australian Figure Skating Championships (AFSC)	\$60 per day for events held outside NSW <sup>^~</sup> \$30 per day for events held in NSW <sup>^~</sup>
ISU Seminars (not held in conjunction with AFSC and only when a seminar has not been offered in Australia within 48 months for the respective discipline and a seminar is held in NSW for local Officials)	\$30 per day per seminar if held in NSW \$300 per seminar if held in Australia but outside NSW Up to \$1,000 per seminar if held overseas*
ISU Examinations	Up to \$1,000 per exam if passed*
International Competitions	\$100 per event

^ Other than Technical Specialists or Assistant Technical Specialists who have a skater or skaters competing in the competition.

~ Panelled Officials only, taken by days officiating on panels for events held in NSW and by days available to be panelled for events held outside NSW.

\* Funding only available if travel & board is not covered by ISU. Funding only available if expenses are not covered by ISA or other parties. If other funding is received, the available funding from NSWISA is only to the value of any expenses that are not already covered. Only one payment is applicable for a combined seminar & exam.

## **5. Payment**

Payments will be made in January each year based on the activities completed in the previous calendar year.

The payments will be as per the Eligibility & Funding criteria above however:

1. Those officials who meet all criteria will receive 100% of the available funding.
2. Those officials who meet all criteria, including officiating at more than 50% of the activities in any category will receive 120% of the funding payable in any categories where their activity is greater than 50%.
3. Those officials who meet all criteria except for meeting only four of the five required activity types will receive a goodwill payment of 60% of the base payment they would be entitled to had they met all criteria required for funding. For 2020 ONLY, officials will be required to meet only three of the five activity types to receive a goodwill payment of 60% of the base payment they would be entitled to had they met all criteria required for funding.

The Board will review the qualification for funding and make any updates as necessary to reflect the changed landscape resulting from Covid-19. Any changes made to this Policy or resulting payments will be at the discretion of the Board.
